A. Arnold Oranje, dermatologist, Rotterdam, The Netherlands:

- <u>Mastocytosis</u>: As an example of a rare disease with a distinuished benign course in children. The type of skin manifestations indicate a good or less better prognosis. In the adult form bonemarrow investigations are recommended, while in children almost never. Therefore the WHO classification is not applicable for children. A International management guideline is available.
